SC gives SBI tongue-lashing, asks it to disclose all details by Mar 21

Chambers of Commerce & Industry of India (AS-SOCHAM) and Confederation of Indian Industry (CII) in the case. The industry bodies, through senior advocate Mukul Rohatgi, wanted an urgent hearing on their interim application against the disclosure of bond details.

Salve told the bench it should not seem that the bank is "playing with" the court as they have no difficulty in disclosing the details of electoral bonds.

Advocate Prashant Bhushan, appearing for the petitioner NGO in the case, claimed that major political parties have not given the donor details and only some parties have given it.

"There is enough assistance by public-spirited citizens," Solicitor General Tushar Mehta said, claiming that these sponsored NGOs are "fudging figures".

The apex court also refused to take note of a letter by senior advocate Adish C Aggarwala, the president of the Supreme Court Bar Association (SCBA), seeking a suo motu review of the judgment on disclosure of electoral bond details.

"Apart from being a senior counsel, you are president of SCBA. You know the procedure," CJI Chandrachud said, adding, "You have written a letter asking me to invoke my suo motu jurisdiction. What is the locus to mention? These are all publicity-oriented stunts. We will not permit it".

"Do not make me say anything more. It will be distasteful," the CJI told Aggarwala, who had written a letter in his personal capacity.

Solicitor General Mehta said on behalf of the Central government, "I completely disassociate myself with what Aggarwala has written. It is completely unwarranted and ill-advised".

He also said that after the apex court's verdict on electoral bonds, "witch hunting has started at some other level, not at the governmental level". Those before the court started giving press interviews, "deliberately embarrassing" the court and this creates a non-level playing field, Mehta said

The solicitor general also referred to social media posts and said that these were intended to cause embarrassment. He stressed that the Centre's case was that they wanted to curb the black money.

To this, the CJI said, "Mr solicitor, we are only concerned about enforcing the direction which we issued. As judges, we decide according to the Constitution. We are governed by the rule of law. We are also the subject matter of comments in the social media and the press.

"Surely, as an institution, our shoulders are broad enough. Our court has an institutional role to play in a polity which is governed by the Constitution and the rule of law. That is the only job," Justice Chandrachud said.

The apex court also refused to entertain an application seeking disclosure of the details of electoral bonds sold from March 1, 2018, to April 11, 2019.

Army raises Elite Unit to work on 6G, AI

considering the future battlefield, they said.

"It will be a premier organisation, the first of its kind equipped with the capability to harness niche technology, leverage cutting-edge solutions and identify suitable cases for defence applications by fostering collaboration with academia and industry," one of the officials said.

The elite unit will focus on all upcoming critical technology domains including electronic exchanges, mobile communications, software defined radios, electronic warfare systems, 5G and 6G networks, quantum technologies, AI, machine learning, etc., he said.

The hi-tech unit will carry out technical scouting, evaluation, development, management of core ICT solutions, and provide user interface support by maintenance and upgradation of contemporary technologies available in the environment, the official added

Army Chief Gen Manoj Pande has been highlighting the need for acquiring new technologies by the force in view of the changing nature of warfare.

"Aligning itself with the tenets of Atmanirbhar Bharat and Start-Up India, STEAG will help bridge the divide between the armed forces on the one hand and industry and academia on the other," the official said on condition of anonymity.

The new Centre of Excellence is expected to be a game changer in fostering self-reliance in high-end communication technologies, which have thus far been a monopoly of select countries with advanced economies and research ecosystems, he said.

The Army believes communications are going to be an important component of military operations.

'In the fast-evolving technologies for the battlefield, the side with better communication technologies and the ability to connect the various constituents for information sharing will have an edge over its adversary," another official said.

He said modern warfare necessitates the induction of new equipment to provide seamless communication support to units and formations during operations.

"To imbibe such advancements in technology, the Indian Army has raised this groundbreaking technology-oriented unit STEAG which will bolster its capabilities in the digital domain," he added.

to create new facts or markers, toponymy (the study of place names), cartographic aggression, or to create a new narrative.

"This again will have to be countered collectively by all of us at all levels, which includes academicians, thinkers, and strategists," the Chief of Defence Staff said.

General Chauhan referred to External Affairs Minister S. Jaishankar's statement wherein he had said that there is more to the Sino-India relations than the border disputes.

'Similarly, in an increasingly inter-connected world, Sino-India relations cannot be viewed in a binary kind of perspective. The rise of China affects other nations as well, and we must look at like-minded nations for an equitable balance while remaining cognisant of the fact that one must be prepared to fight its own battle," the Chief of Defence Staff said.

Speaking about the challenges related to technology, General Chauhan said as technology emerges as the new currency of power, there is a tendency of nations to deny competitors.

"Technology denial regimes existed in the past, but what we are witnessing now is a race to retain technological edge. India cannot afford the emergence of a major technological gap between us and our immediate adversaries, and that would be fatal for us," the Chief of Defence Staff said.

He said this "battle of increasing technological gap" has to be fought not only by soldiers but also by academics, scientists, and everyone as a nation together.

General Chauhan also spoke about the challenge of rising fragility and the outcome of political, social, and economic stability in the immediate neighbourhood.

"India seems to be the only island of stability in a sea of turmoil and turbulence. Political, social, and economic instability in countries in our immediate neighbour ood make them vulnerable to foreign influence," he said.

inside Afghanistan; Taliban reacts

Afghanistan provinces of Paktika and Khost along the Pakistan border have taken place. There was no immediate reaction from the Pakistani side

At "around 3 am, Pakistani aircraft bombarded civilian homes" in Khost and Paktika provinces near the border with Pakistan, Mujahid said, claiming that all eight people killed were women and children.

Mujahid said that Pakistani planes had bombed the Laman area in Paktika's Barmal district.

Alleging that "houses of common people were targeted" he said three women and three children were killed in Paktika and a house collapsed while two women were killed in Khost, where a house was destroyed as well.

"The Islamic Emirate strongly condemns the attacks and describes these as non-serious actions and violation of Afghanistani territory," Mujahid said.

The spokesperson asked Pakistan to stop blaming Afghanistan for its problems and failure to control violent incidents.

"Such acts can lead to dire consequences which will not be in control of Pakistan," he warned.

The strikes come a day after President Asif Ali Zardari vowed retaliation following the killing of seven soldiers, including two officers, in a terrorist attack on a security forces' post in North Waziristan.

Offering the funeral prayers of the two officers, Zardari on Sunday said that the blood of the martyrs would not go in vain and the country would avenge the deaths. The president said Pakistan would not hesitate to strike back if attacked by anyone at borders or inside its territory.

The Hafiz Gul Bahadar group had claimed responsibility for the deadly attack. Security officials say that fighters of the Gul Bahadar group operate from the Afghan side of the border. mostly from Khost.

The Paktika province is located near Pakistan's South Waziristan District while Khost is situated near North Waziristan.

Pakistan's Special Representative to Afghanistan Ambassador Asif Durrani on Saturday said that an estimated 5,000 to 6,000 militants from the banned Tehreek-i-Taliban Pakistan (TTP) have taken shelter in neighbouring Afghanistan.

"If we include their families, then the number goes up to 70,000," Durrani said.

Reacting to Durrani's charge, Afghanistan has dismissed his statement, saying that Afghan soil is not allowed to be used against other countries, including Pakistan.

"We reject the presence of any ... foreign groups in Afghanistan and they are not allowed to operate on Afghan soil. In this regard, we have made our utmost effort and continue to do so. But one thing we must accept is that Afghanistan shares a very long border area with Pakistan, and there are places with rugged terrain including mountains and forests, and places that might be out of our control," Zabihullah Mujahid was quoted as saying by Tolo News on Sunday.

Durrani, who spoke at a think-tank event in Islamabad last week, said Pakistan's peace talks with the banned TTP failed in the past because the militant group was neither ready to surrender nor swear allegiance to the Constitution of Pakistan.

Durrani said Pakistan had told the interim government in Kabul that the latter needed to make TTP surrender and disarm the group and detain its leadership. He clarified that "TTP is the redline for Pakistan".

The TTP, which has ideological linkages with the Afghan Taliban and is also known as the Pakistan Taliban, was set up as an umbrella group of several militant outfits in 2007.

"There is no evil he will not commit to prolong his personal power," Zelensky said.

As early as Friday, the first day of voting in the election, EU chief Charles Michel had sarcastically congratulated Putin on his "landslide victory"

If he completes another full Kremlin term, Putin will have stayed in power longer than any Russian leader since Catherine the Great in the 18th century.

Allies of the late Alexei Navalny -Putin's most prominent rival, who died in an Arctic prison last month - had tried to spoil his inevitable victory, urging voters to flood polling stations at noon and spoil their ballots.

His wife, Yulia Navalnaya, was greeted by supporters with flowers and applause in Berlin. After voting at the Russian embassy, she said she had written her late husband's name on her ballot.

Some voters in Moscow answered the call from the opposition, telling AFP they had come to honour Navalny's memory and show their opposition in the only legal way possible.

"I came to show that there are many of us, that we exist, that we are not some insignificant minority," said 19-yearold student Artem Minasyan at a polling station in central Moscow.

Putin said the protest had had no impact and that those who spoiled their ballots would "have to be dealt with".

In his first public comments on Navalny's death last month, Putin called his passing a "sad event"

Using his name in public for the first time in years during a televised news conference, Mr. Putin said: "As for Navalny. Yes, he passed away. This is always a sad event."

Putin said a colleague had proposed swapping Navalny several days before he died for "some people" who are cur-

rently held in prisons in Western countries. "The person who was talking to me hadn't finished his sentence and I said 'I agree'"

Former Russian leader Dmitry Medvedev meanwhile congratulated Putin on his "splendid victory" long before the final results were due to be announced.

And state-run television praised how Russians and rallied with "colossal support for the president" as well as the "unbelievable consolidation" of the country behind its leader.

At Navalny's grave in a Moscow cemetery, AFP reporters saw spoiled ballot papers with the opposition leader's name scrawled across them on a pile of flowers.

"We live in a country where we will go to jail if we speak our mind. So when I come to moments like this and see a lot of people, I realise that we are not alone," said 33-year-old Regina.

There were repeated acts of protest in the first days of polling, with a spate of arrests of Russians accused of pouring dye into ballot boxes or arson attacks.

Any public dissent in Russia has been harshly punished since the start of Moscow's offensive in Ukraine on February 24, 2022 and there were multiple warnings from the authorities against election protests.

The OVD-Info police monitoring group announced that at least 80 people had been detained across nearly 20 cities in Russia for protest actions linked to the elections.

"We have called a strike and protest rally to put all types of rumours to rest. Everyone in Ladakh is part of the agitation and united in support of the demands," he said.

Karbalai said the leadership of both KDA and Apex body are shortly meeting in Leh or Kargil to chalkout the future strategy after the Centre's rejection of the main demands statehood and constitutional safeguards under the sixth schedule.

Putin vows Russia can't be held back in victory speech

Russian territory by pro-Kyiv sabotage groups and vandalism at polling stations

The Kremlin had cast the election as a moment for Russians to throw their weight behind the full-scale military operation in Ukraine, where voting is also being staged in Russian-controlled territories.

Putin singled out Russian troops fighting in Ukraine for special thanks in his post-election speech in Moscow.

And he was unrelenting in claiming his forces had a major advantage on the battlefield, even after a week which saw Ukraine mount some of its most significant aerial attacks on Russia and in which pro-Ukrainian militias barraged Russian border villages with armed raids.

The initiative belongs entirely to the Russian armed forces. In some areas, our guys are just mowing them - the enemy - down," he said.

7 killed in Kolkata building collapse, CM Mamata assures stern action against illegal construction

KOLKATA, MARCH 18: At least seven people, including two women, were killed and several others injured after an under-construction fivestorey building collapsed in the Garden Reach area of Kolkata, police said on Monday

The toll could go up since at least four people were spotted trapped under the debris, 16 hours after the collapse, and only one of them showed signs of life, a fire services official engaged in rescue operations said.

Kolkata Mayor Firhad Hakim said the rescue operations were carried out on war footing at the site where the building was being constructed illegally

While Md Wasim, the promoter of

the building, was arrested, the mayor said stringent action would be taken as per law.

Chief Minister Mamata Banerjee visited the building collapse site at Azan Molla Lane in the city's western periphery and assured locals of stern action against illegal construction.

In a horrific accident, the underconstruction five-storey building collapsed around midnight, Hakim said.

"We are using gas cutters and other equipment to clear the debris and reach those who are stuck underneath. It's taking a long time since we are proceeding cautiously towards the victims," the fire services official told PTI, adding that the personnel from NDRF, the state and Kolkata Police disaster



management teams were also working bris, rescue workers are finding it tough to reach those who have been Owing to the massive pile-up of detrapped, he said.

"We have compiled a list of victims of the building collapse. Seven people died and two of them were women. Of the 15 injured people, 11 are undergoing treatment at hospitals and four were discharged after preliminary treatment," a senior officer said.

"Sad to learn about the house collapse disaster of an under-construction building in the Garden Reach area of the Kolkata Municipal Corporation. **Our Mayor, Fire Minister, Secretaries** and Commissioner of Police, civic, police, fire and disaster management officers and teams (including NDRF, KMC and KP teams) have been on site throughout the night for mitigating the disaster," the chief minister wrote on X.

She said the government will provide compensation to the next of kin of each deceased and the injured persons

"We stand by the distressed families and rescue operations shall continue," Banerjee said on the microblogging

Hakim, also West Bengal's urban development minister, said, "I spoke to the chief minister and we will provide Rs 5 lakh to the next of kin of each deceased and Rs 1 lakh to each injured person."

TMC national general secretary Abhishek Banerjee said the building collapse incident is "extremely sad" and asserted that it should not be politicised.
